GUIDANCE NOTES

1. This form applies to operatives employed in the industrial rope access industry and should be used for any of the following:
 - a) Formal registration of an operative following assessment - TICK FIRST BOX OVERLEAF
 - b) Up-grading and re-registration following assessment - TICK SECOND BOX OVERLEAF
2. The form should be completed and signed by a senior manager or director to whom these notes are addressed.
3. Please ensure that the form is completed fully, in particular the national insurance number (NI number) and the full address, including postcode.
4. You must send with the form:
 - a) Three copies of a photograph of the operative, obtained at your own expense. They should be full face, head and shoulders, colour or black and white and visual passport size, i.e. 4.5 x 3.5 cm. You must write on the back of each "I certify that this is a true likeness of (name)" and add your signature. The signature on the photograph must be the same as that of the person making the recommendation.
 - One copy of the photograph must be securely attached to this form where indicated.
 - One copy of the photograph will be included in the IRATA logbook.
 - One copy of the photograph will be included in the IRATA identity card. (N.B. Identity cards are only issued when the operative has been assessed by an IRATA assessor.)
 - b) The operative's IRATA assessment form, completed and signed as appropriate.
